In the Name of God Amen I Charles Lampard late of the Parish of East Noyle in the County of Wiltshire Labourer but now Serjeant in his Majesty's 98th Regiment of ffoot under the Command of Lieut Colonel ffullarton now Doing Duty on Board his Majesty's Ship the Burford Peter Rainer Esquire Captain and Commander under the Command of Sir Edward Hughes Knt of the Bath Vice Admiral of the Blue on the East India Station being in perfect Health and of sound and disposing mind memory and understanding but considering the Uncertainty of this Transitory life in War and other Cases Do publish and declare this my last Will and Testament in manner and form following (that is to say) my Body I commit to the Earth or Sea as it shall please God to order and as to my Pay arrears of pay Prize Money and all other Sum and Sums of Money whereof I shall be Seized Possessed Intitled or Entitled unto at the time of my Decease I give Devise and bequeath the

same unto my Daughter Catherine Lampard at Mr James Specks Grocer and Chandler at Tetbury in Gloucestershire for her Sole and Separate use and benefit and I do hereby Appoint my said Daughter Catherine Lampard Sole Executrix of this my last Will And as to my Cloathing Money Necessaries And what my Box and Bag contains I leave to my Messmates And in case of my Daughter's Decease I will and bequeath the above mentioned Pay arrears of pay Prize Money and all other Sum and Sums of Money at my decease unto my Sister Sarah Matthews of the Parish of East Noyle in the County of Wilts aforesaid her Heirs Executors Administrators Assigns And Lastly I do revoke all former Wills by me heretofore made or Executed and declare this to be my last Will and Testament In Witness whereof I have hereunto set my hand and seal this Sixth Day of April in the Year of our Lord one thousand seven hundred and eighty three *Charles Lampard*
