Shop Yard Garden and hereditaments thereunto belonging situate at Axford in the Parish of Ramsbury in the County of Wilts now in my own occupation and all other my real estate whatsoever and wheresoever to hold the same and every part thereof for her own natural life and from and immediately after her decease I give and bequeath and devise the same to my daughter Jane Vickers her heirs executors administrators and assigns and I do hereby nominate and appoint my said daughter Jane Vickers of Axford in the Parish of Ramsbury in the County of Wilts sole Executrix of this my last Will and Testament upon trust that she the said Jane Vickers her heirs executors administrators and assigns do and shall with all convenient speed after my decease call in my debts and convert into money my said personal estate or such parts thereof as shall consist of money And I do hereby revoke and make void all former and other Wills by me at any time heretofore made and I do declare this only to be my last Will and Testament In
