1799

The Hon. and Rev. Edw. Seymour, A.M. is presented, by the Lord Chancellor, to the rectory of Upton Lovell, in this county, vacant by the death of the Rev. Mr. Crouch.

1834

The Rev. J. Vaughan, LL. B., Rector of Holmpton, Yorkshire, has been instituted to the Rectory of Upton Lovell, Wilts, on the presentation of the King. Salisbury and Winchester Journal, Monday, 17 March 1834

1841

We learn that the Rev. John Vaughan, LL. B. (the eloquent and powerful preacher), Rector of Upton Lovell, is about to relinquish the pastoral care of that village for the more onerous duties of the populous parish of Brixton, Surrey. Salisbury and Winchester Journal, Monday, 15 November 1841

The Rev. Edwin Prodgers, B.D., has been instituted by the Lord Bishop of Salisbury to the Rectory of Upton Lovell, in this county, void by the cession of the Rev. John Vaughan, on the presentation of the Lord Chancellor. Salisbury and Winchester Journal, Monday, 29 November, 1841

1842

On the 5th inst., the Rev. William Gray, clerk, was instituted by the Lord Bishop of this diocese to the Rectory of Upton Lovell, in this county, void by the cession of Edwin Prodgers, clerk, on the presentation of her Majesty the Queen. Salisbury and Winchester Journal, Monday, 18 April 1842

The Rev. E. Prodgers, B.D., Rector of Upton Lovell, in this county, has been instituted by the Lord Bishop of Lincoln, to the Rectory of Ayott Saint Peters, Hertfordshire, (£350 per annum) void by the cession of the Hon. And rev. P. G. Saville, clerk on the presentation of the Earl of Hardwicke. The acceptance of this preferment has rendered void the former living to which an institution took place a few weeks ago, as announces in a former number.
