This is the last Will and Testament of me George Dallimore of Radstock in the County of Somerset but now of Warminster in the county of Wilts I give and bequeath unto my brother Horatio Nelson Dallimore the sum of one hundred pounds sterling to be paid to him by my executors hereinafter named within six calendar months next after my decease for his own benefit I also give and bequeath unto each of my said executors the sum of five guineas sterling to purchase a ring I give devise and bequeath All my real and personal estate unto and to the use of John Abraham and Joseph Abraham both of the City of Bristol Wine Merchants their heirs executors administrators and assigns according to the respective natures and qualities of the said premises Upon trust that they or the survivor of them his executors or administrators or other the trustees or trustee for the time being of this my will shall with all convenient speed after my decease collect all moneys owing to my estate And I hereby empower my said trustees or trustee to refer to arbitration any dispute that may arise concerning any debts claimed to be owing to or by me And also to compound any debt or debts owing to me without being responsible for any loss that may be thereby incurred And I also direct my said trustees or trustee to sell all my real estates whether freehold or leasehold and also to convert into money all such parts of my personal estate as shall be saleable And I hereby empower my said trustees or trustee to sell my real and personal estate by public auction or private contract and also to enter into all such contracts respecting such sales as they or he may deem expedient and to buy in and resell the whole or any part of my said trust estate and premises without being responsible for any loss that may be

incurred in consequence And also to convey and assure the said trust estate and Premises when sold to the purchaser or purchasers thereof or to such uses as he or they shall direct And I hereby declare that the receipts of my said trustees or trustee shall exonerate the parties taking the same from the payment of all moneys therein expressed to be received or from seeing to the application thereof And I direct my said trustees or trustee for the time being out of the money which shall arise from the sale and conversion of my said real and personal estate in the first Place to pay all my just debts funeral and testamentary expences and the costs of the sales hereinbefore directed to be made or otherwise to be incurred in or about the execution of the trusts of this my Will and in the next place to pay and retain the several pecuniary legacies hereinbefore begueathed And as to the residue of the said trust moneys to pay the same unto my son Frederick William Dallimore now residing at Melbourne Port Philip Australia for his own absolute benefit Provided always And I hereby declare that if my trustees hereinbefore named or either of them or any trustee or trustees to be appointed under the present clause shall die or go to reside beyond the seas or intend so to reside or be unwilling or incompetent to execute the trusts or powers of this my Will it shall be lawful for the competent trustee for the time being (if any) whether in writing from the office of trustee or not or (if none) for the heirs executors or administrators of the last surviving trustee by any writing under his or their hand or hands to constitute any fit person or persons in whom alone (or as the case may be) iointly with any surviving trustee or trustees my trust fund shall be vested And I exempt every trustee of my Will from liability for losses occurring without his own wilful default and authorize him to retain to himself and to allow his co trustee all expences incidental to the trusteeship And I appoint the said John Abraham and Joseph Abraham Trustees and Executors of this my Will And I hereby revoke all Wills and Testamentary writings by me heretofore made In Witness whereof I the said George Dallimore have to this my last Will and Testament contained in this and two preceding sheets of Paper set my hand this fourteenth day of April in the year one thousand eight hundred and fifty one - George Dallimore

On the 19th day of April 1854 Admon (with the Will annexed of the goods chattels and credits of George Dallimore of formerly Radstock in the County of Somerset but late of Warminster in the county of Wilts deceased was granted to Horatio Nelson Dallimore the brother a legatee named in the said Will having been first sworn by Comon duly to administer John Abraham and Joseph Abraham the Executors and Universal Legatees in trust named in the said Will having renounced the Probate and execution of the said Will and also the Letters of Admon (with the said Will annexed) of the Goods of the said Deceased Frederick William Dallimore the son the residuary Legatee named in the said Will having first been duly cited with the usual but in no wise appeared (as by Acts of Court appears)
