## 3 The minutes of the last meeting of the Council

The minutes were proposed by Cllr Francis and seconded by Cllr Johnson and accepted by the Council.

#### 4 Chairman's announcements

Cllr Wilshire met Sovereign Housing Association representative, and they confirmed that they would remove the hedge detritus from Whatleys. Pavement opposite the Grange is in a dangerous state, and the Mill Race footpath has not been kept up on request as promised. Clerk to inform WC

## 7 Neighbourhood Planning - update from the group

Terms of Reference have been agreed by the group, and a top level vision was put together by the group this was circulated to the Council. The idea is that if everyone is happy with the Vision, the Vision will be the basis of a letter to residents in November with some Housing Need Assessment questions, followed by a public meeting before Christmas.

The Group now has a Link Officer with Wiltshire Council with the help of Cllr Gamble - Mr O'Donoghue – he will confirm what day he is able to meet the group.
