twenty eighth day of June One thousand eight hundred and nineteen for the lives of ELIZABETH ARCHER / late ELIZABETH POPE / and GEORGE POVEY And also all my Estate and Interests in the said Copyhold premises To hold to him the said GEORGE GRIST his executors administrators and assigns absolutely I also bequeath all the furniture, plate, linen, china, glass, cooks, prints, pictures, and consumable provisions and other household effects of which I shall die possessed unto the said GEORGE GRIST absolutely but subject nevertheless as to all the said Copyhold premises and chattels and effects to the payment of my just debts and funeral and testamentary expenses And as to all the residue of the real and personal property whatsoever and wheresoever which may be vested in or belong to me at my decease I devise and bequeath the same to my son JOHN GRIST / the father of the said GEORGE GRIST / his heirs exexcutors and administrators according to the nature and qualities thereof respectively but subject as to properly vested in me as trustee or mortgagee to the trusts and equities affecting the said respectively I appoint JOHN JOHNSON of Little Hinton in the said County of Wilts Yeoman sole Executor of this my Will and I declare that his receipts for such monies securities and other effects as shall be paid or transferred to him by virtue of my Will shall effectually discharge paying or transferring the same from liability to see to the application thereof And I absolve my said Executor from responsibility for involuntary losses, and also authorize him to retain all expenses of executing my Will. And lastly I revoke all former Wills. In Witness whereof I have hereunto set my hand the twenty seventh day of November One thousand eight hundred and forty nine
