This is the last Will and Testament of me Thomas Spackman of Poulton in the Parish of Bradford in the County of Wilts Gentleman as touching the disposition of my temporal Estate as follows ffirst I direct my just debts funeral and testamentary expences to be paid and discharged by my executors herein after named out of my personal Estate I give and devise unto my son Thomas Spackman and to my Cousin Thomas Spackman of Bradford Leigh all those my two messuages or tenements gardens and premises situate lying and being in the Parish of Trowbridge in the said County of Wilts now in the respective occupations of Ann Tiley and James Shipway as tenants thereof and also all that my messuage and tenement garden and premises situate lying and being at Newtown in the Parish of Bradford aforesaid now in the respective occupations of John Hancock and Catharine Hancock as tenants thereof to hold the same messuages or

tenements gardens and premises with the appurtenances unto my said son Thomas Spackman and Thomas Spackman of Bradford Leigh their heirs and assigns for ever upon the trusts and for the intents and purposes hereinafter mentioned and declared of and concerning the same (that is to say) in trust for my two daughters Mary Ann Spackman and Betty Caroline Spackman their heirs and assigns for ever as tenants in common and not as joint tenants but in case of the death of either of my said daughters unmarried and without leaving lawful issue then in trust for the survivor of them her heirs and assigns for ever also I give and bequeath unto my said two daughters Mary Ann Spackman and Betty Caroline Spackman all and singular my goods chattels and implements of household plate linen and china money and securities for money and all other my Personal Estate and Effects whatsoever and wheresoever and of what nature or kind soever which I may be possessed of or entitled unto at the time of my decease (except my silver watch and chain and gold seal hereafter mentioned) and subject to the payment of my just debts funeral and testamentary expences unto my said daughters Mary Ann Spackman and Betty Caroline Spackman equally between them share and share alike also I give and bequeath unto my grandson Thomas Spackman son of my son John Spackman my before mentioned Silver watch and chain and to Thomas Spackman son of the said Thomas Spackman of Bradford Leigh my old seal with the Crest and the initials GS engraved thereon also I constitute and appoint my said son Thomas Spackman and the said Thomas Spackman of Bradford Leigh joint Executors of this my Will And lastly I hereby revoke all former Wills by me at any time made and declare this only to be and contain my last Will and Testament In Witness whereof I have to this my Will contained in two sheets of paper to the first sheet thereof set my hand and to this second and last my and seal this third day of May in the year of our Lord one thousand eight hundred and thirty seven Thos Spackman
