In the name of God Amen The 15th day of May in the year of our Lord God One Thousand Six Hundred Fifty-Five George Antram of the City of New Sarum in the County of Wilts Parchment Maker being weak of body but of sound and perfect memory thanks be given to God do make and ordain this my last Will and Testament in manner and following: that is to say first I commend my soul into the hands of Almighty God my creator absolutely trusting through the merits of Jesus Christ my only saviour and redeemer to be made partaker of life everlasting and my body I commit to the earth of whence it came in hope of a joyful resurrection Item I give to the poor of the Parish of St. Martin within the said city ten shillings to be disposed of by my executor hereinafter named as she shall see fit Item I give unto my son Ellis Antram five pounds and to his son twenty shillings Item I give unto my son William Antram twenty shillings and to all his four children twenty shillings a piece Item I give unto my daughter Sarah five pounds and to her five children twenty shillings a piece Item I give unto my daughter Mary ten pounds and to her five children twenty shillings a piece the said several legacies to be paid within one month next after my decease Item I give unto my son Robert Antram five pounds to be paid within one year after my decease and to his four children twenty shillings a piece to be paid and disposed to them and their benefit as my overseers hereafter named shall think fit Item I give unto my son George all my stock and goods within the house upon my copyhold tenement in Broadchalke in the County of Wilts paying the heriot to be due to the Lord thereof upon my decease Item I give unto my said sons Robert and William all my harrows for making of parchment to be equally divided amongst them All the rest and residue my goods and chattels whatsoever I give unto my loving wife Joane whom I do now make sole executrix of this my last Will and Testament and I appoint my brother William Richardson and John Good overseers of this my Will and give them two shillings six pence a piece in token of my love In witness whereof I have hereunto set my name and seal the day and year above written George Antram
