This is the last Will and Testament of me Uriah Brodribb of Warminster in the County of Wilts Gentleman I direct that all my just debts funeral and testamentary expences shall in the first place be paid or satisfied as soon as conveniently may be after my decease I give and devise my ffreehold dwelling house Shop Warehouse and Premises situate in the market place in Warminster aforesaid formerly in my own Possession but now in the occupation of my Son James Dudden Brodribb together with the appurtenances Shop and all other fixtures in and about the said dwelling house and premises To such uses and for such intents and purposes as the said James Dudden Brodribb by any deed or deeds instrument or instruments in writing or by his last Will and Testament in writing to be signed and published by him in the presence of and attested by three credible witnesses shall appoint or devise and in default of such appointment or devise To the use of him the said James Dudden Brodribb his heirs and assigns for ever But in case the said James Dudden Brodribb shall depart this life during my life time Then I give and devise the same dwelling house Shop Warehouse and hereditaments and Premises unto all and every the Child and Children of the said James Dudden Brodribb living at my decease equally to be divided between them as tenants in common and not as joint tenants and their respective heirs and assigns for ever and if there shall be only one such Child then to such only Child his or her heirs and assigns for ever I give and devise my dwelling house Surgery and Premises (formerly two dwelling houses) with the Appurtenances situate in Warminster aforesaid purchased by me of the devisees in Trust of the late Edward John Middlecott Esquire deceased and now in the possession of my Son William Perrin Brodribb To such uses and for such intents and purposes as the said William Perrin Brodribb by any deed or deeds instrument or instruments in writing or by his last Will and Testament in writing to be signed and published by him in the presence of and attested by three credible witnesses shall appoint or devise and in default of such appointment or devise To the use of him the said William Perrin Brodribb But in case the said William Perrin Brodribb shall depart this life during my life time Then I give and devise the same dwelling house Surgery hereditaments and Premises unto all and every the Child and Children of the said William Perrin Brodribb living at my decease equally to be divided between them as tenants in common and not as joint tenants and their respective heirs & assigns for ever and if there shall be only one such Child then to such only Child his or her heirs and assigns for ever I give and bequeath unto my Children next hereinafter mentioned (that is to say) To my daughter Elizabeth Randall the Sum of three hundred pounds To my daughter Ann Slater the Sum of three hundred pounds To my Son Uriah Brodribb the Sum of three hundred pounds To my Son Samuel Brodribb the Sum of three hundred pounds To my Son Charles Brodribb the Sum of three hundred pounds To my Son ffrancis Bower Brodribb the Sum of three hundred pounds To my Son Henry Brodribb the Sum of three hundred pounds And in case any or either of them my said last named eight children shall depart this life during my life time Then I give and bequeath the Sum or Sums bequeathed to him her or them so dying as aforesaid unto his her or their Child or Children living at my decease equally between them if more than one as tenants in common And in case of the death of either or any of my said last named eight children in my lifetime without leaving a Child or Children living at my decease I declare the legacy or legacies given to such my Child or Children dying in my lifetime without leaving a Child or Children living at my decease shall sink into my residuary estate I give to Mary Joyce ten pounds as a token of my remembrance of her attention to my late dear Wife I also give to my Servants Sarah Clark and Elizabeth White the Sum of ten pounds each and to John Langley the Sum of five pounds And I devise and bequeath all the rest residue and remainder of my freehold Copyhold and Leasehold estates messuages lands tenements and hereditaments monies and securities for money Stocks funds goods chattels real and personal estate of what nature or kind soever not hereinbefore disposed of with their respective rights members and appurtenances unto and to the use of my said Sons James Dudden Brodribb Uriah Brodribb William Perrin Brodribb and my Son in law Edward Mayor Randall their heirs executors Admors and assigns according to the nature and tenure of the said estates and Premises respectively Upon trust that they the said Trustees or the Survivors or Survivor of them his heirs executors or admors do and shall with all convenient speed after my decease call in and convert into money all my said residuary personal Estate And also do and shall as soon as convenient after my decease either by public sale or private contract or partly by both means make sale and absolutely dispose of all and singular my Estates Messuages Lands Tenements and hereditaments and Premises (not already disposed of by this my Will) either together or in parcels for the best prices that can reasonably be obtained for the same and to assure the same to the Purchaser or Purchasers thereof or in such manner as he she or they shall direct And I declare that the receipt or receipts of the said Trustees or Trustee for the time being shall exonerate such Purchaser or Purchaser from seeing to the Application of the money therein acknowledged to be received And I do hereby declare that the receipt or receipts of the said Trustees or Trustee for the time being shall stand possessed of such part of my residuary Personal Estate as shall consist of money and the monies to arise from such other part of my said residuary Personal Estate as I have hereinbefore directed to be converted into money and also the monies to arise from the hereditaments and premises hereinbefore directed to be sold Upon Trust that they the said trustees or trustee for the time do and shall stand and be possessed thereof Upon Trust to pay and divide the same in equal shares and proportions unto and among all my Children who shall be living at my decease and such of the issue of such Child or Children of mine then dead leaving issue such Child or Children and issue objects of this present trust to take equally among them as tenants in common the share or respective shares only which the parent or respective parent of such issue would have taken if living at my decease per stirpes and not per capita And I do declare that in case any or either of my said Children shall be indebted to me at the time of my decease for any Sum or Sums of money advanced by me to or for the use or benefit of such Child or Children either before or after the date of this my Will and for which I shall

hold any bond Bill Promissory Note or other security nothing contained in this my Will shall be considered a release of such debt or debts but the same shall be paid and accounted for to my Estate before such Child or Children shall receive any Legacy or share of residue by virtue of this my Will And I further declare that the said trustees or Trustee for the time being of this my Will shall be chargeable only for so much money as they or he shall respectively actually receive by virtue or under this my Will or in the execution of the trusts herein declared and contained notwithstanding their joining in receipts for conformity and that any one or more of them shall not be answerable or accountable for the other or others of them nor for involuntary losses but each for his own acts receipts neglects or defaults only And that my said Trustees or Trustee for the time being shall and may out of the monies that shall come to their respective hands by virtue of this my Will retain to and reimburse themselves and himself respectively and also allow to their and his Co Trustees and Cotrustee all costs charges damages and expences which they shall or may respectively sustain expend or be put unto in or about the execution of the trusts of this my Will or any of them And I hereby nominate constitute and appoint my said Sons James Dudden Brodribb Uriah Brodribb William Perrin Brodribb and my said Son in Law Edward Mayor Randall Executors in trust of this my Will And I hereby express my earnest hope that nothing will arise out of the arrangements I have made in regards to the division of my Property among my dear Children which shall in any degree disturb their family union and harmony but that they will always live in the greatest brotherly love and affection as well out of respect to my memory as to that of my late dear mother and should any question whatsoever arise I earnestly recommend them to refer it to the decision of some friend or friends without having recourse to any specie of litigation And in order to avoid all doubt of or difficulty in proving at any time the respective periods of birth of my Children which might otherwise arise either from the loss of the Register of Baptisms kept at Common Close in Warminster aforesaid (in which they are all registered) or from any other cause whatsoever I do hereby declare the same to be as follows namely Elizabeth Randall now the Wife of Edward Mayor Randall was born on the third day of October one thousand seven hundred and ninety six James Dudden Brodribb was born on the fifteenth day of October one thousand seven hundred and ninety eight Uriah Brodribb was born on the twenty seventh day of November one thousand seven hundred and ninety nine William Perrin Brodribb was born on the sixteenth day of November one thousand eight hundred Samuel Brodribb was born on the twentieth day of January one thousand eight hundred and four Charles Brodribb was born on the third day of March one thousand eight hundred and five Edward Brodribb was born on the fourteenth day of ffebruary one thousand eight hundred and six ffrancis Bowers Brodripp was born on the twenty fifth day of ffebruary one thousand eight hundred and seven Ann Brodribb (now the Wife of William Slater of the City of Bath) was born on the seventh day of May one thousand eight hundred and eight and Henry Brodribb was born on the seventeenth day of August one thousand eight hundred and nine And lastly hereby revoking all former and other Wills by me at any time heretofore made I declare this only to be my last Will and Testament In Witness whereof I have to the first four sheets of this my last Will and Testament contained in five sheets of paper set my hand and to this fifth and last sheet set my hand and Seal this tenth day of April in the Year of our Lord one thousand eight hundred and thirty three Uriah Brodribb
