In the Name of God Amen I Timothy Crips of Wotton Bassett in the County of Wilts being weak in body but in good and perfect mynd and memorie doe now make and ordeine my last Will and Testament in writing in maner and forme following And herein I bequeath my Soul unto Almightie God, nothing at all doubting, but that through the Merits of his onely Sonn Jesus Christ Our Saviour my Synnes shall be taken away, And as touching my Bodie I commend it to the Earth from whence it came. And as touching my worldly estate whereof and wherewith it hath pleased God to bless me and endow me withall I give devise and bequeath the same in maner and forme following Imprimis I give and bequeath unto my Grandchild Anne Rumble now living with mee ten pounds of good money of England to be payd her at her Age of one and twentie yeares or her day of marriage which shall first happen; And my will and meaning is, that my Executors shall provide for and keep my said Grandchild Anne till Shee comes to the age of Discretion And as touching and concerning all my Lands tenemts and houses which I am in any wayes seised of I give bequeath and devise the same unto Joan Cripps my loving wife and to Timothy Cripps my Sonn for and during their joynt Lives and the life of the longest Liver of them, And from and after their deceases to the heires & assignes of the Survivour of them the said Joan my wife and Timothy Crips my Sonn forever Alsoe I give to Joan and Ann my Daughter twelve pence apeece And as touching and concerning all the rest and residue of my household stuffe and utensils of household Goods Chattels Corne Cattle and estate I will give devise and bequeath unto my loving wife Joan and to Timothy Crips my Sonn whome I doe hereby ordaine and make my sole and onely Executors of this my last Will and Testament, utterly revoking all other Wills by mee
